Built in 1993, the Becker Building is one of the tallest, and perhaps most unique, buildings in the Peoria area. The exterior is dominated by large blue windows encompassing most of the outside walls, which, along with its interesting architectural design, distinguishes the building amongst the Peoria skyline. Its location in the heart of downtown Peoria is near both the State and Federal Courthouses, making it an ideal location from which to serve our clients.



In addition to providing an updated look and feel, our move has also considerably expanded the size of our office. Our new offices encompass the entire Fourteenth Floor, and has increased the size of our space from just over 9,000 square feet to over 12,000 square feet. This has allowed us to more fully integrate our title company, Endeavor Title Services, with the rest of our firm physically, which in turn allows us to better integrate the operational aspects of the multiple services we provide. We have also been able to add multiple conference rooms to be able to meet with our clients, and have space to grow our firm as we see fit to meet the needs of those we serve.



## PARKING AND DIRECTIONS

- Our office is located at 401 Main Street, Suite 1400, Peoria, IL 61602.
- We occupy the entire 14<sup>th</sup> floor of the Becker Building, otherwise known as the Busey Bank Building.

### PARKING

- When you visit us, you can park on the street or in the Twin Towers Garage under our building.
- The Twin Towers Garage entrance is located at 410 Fulton Street, Peoria, IL 61602. **Please note there is a 6 foot height limit on vehicles parking in the Twin Towers Garage.**
- Street parking is available on Main Street, Fulton Street, Jefferson Street, and Madison Avenue.

### DIRECTIONS TO TWIN TOWERS GARAGE ENTRANCE

#### From Interstate 74 (Westbound)

- Head west on I-74
- Take exit 93 for Adams Street/U.S. 24/Illinois 29 toward Jefferson Avenue/Downtown Peoria
- Continue straight onto Spalding Avenue
- Use the left 2 lanes to turn left onto NE Jefferson Street
- Continue straight on NE Jefferson Street
- Turn right onto Fulton Street
- Your destination, the Twin Towers Garage, will be on your right
- Once you have entered the parking deck, please follow the signs for Becker Building parking
- Please take the Becker Building elevator to our office on the 14<sup>th</sup> floor of the Becker Building

#### From Interstate 74 (Eastbound)

- Head east on I-74
- Use the right lane to take exit 93 for Washington Street toward US-24/IL-29
- Turn right onto Northeast Washington Street (signs for US 24 W/Illinois 29 S)
- Turn right onto Main Street
- Turn left at the 2nd cross street onto SW Jefferson Avenue
- Turn right onto Fulton Street
- Your destination, the Twin Towers Garage, will be on your right
- Once you have entered the parking deck, please follow the signs for Becker Building parking
- Our office is located on the 14<sup>th</sup> floor of the Becker Building

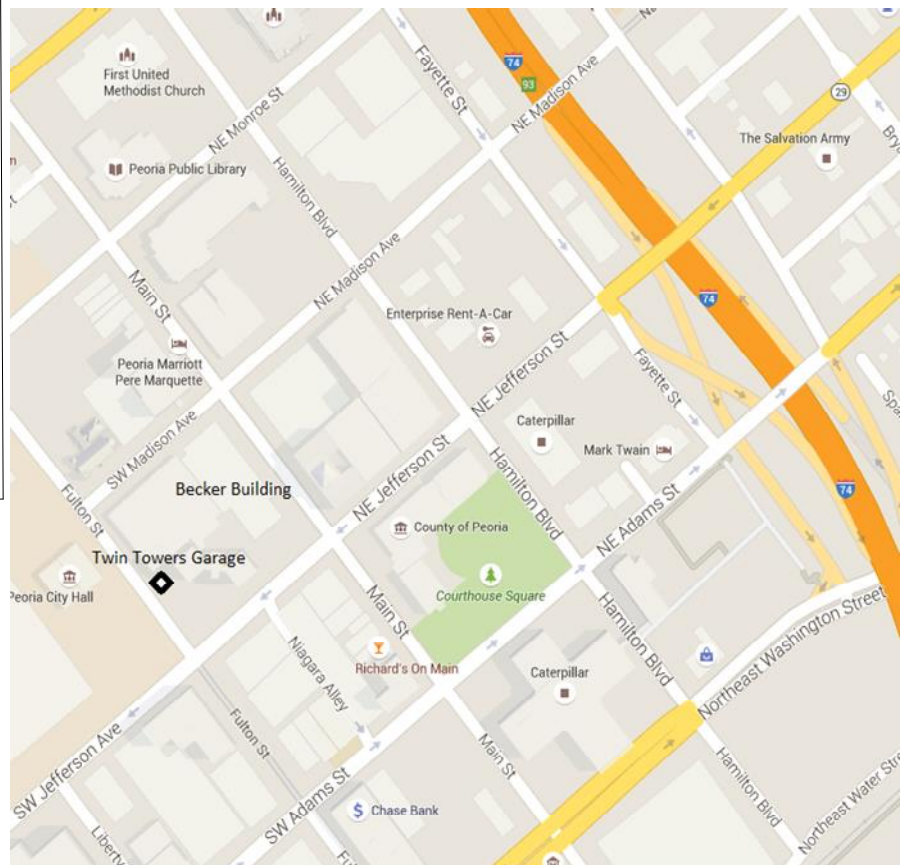
