# RETIREMENT ACCOUNT CONTRI-BUTION LIMITS INCREASED FOR 2012

Changes announced by the IRS for the 2012 tax year will allow more money to be put into tax favorable retirement accounts. The IRS has raised the contribution limit for 401(k)s, 403(b)s, governmental Thrift Savings Plans, and some 457 plans from \$16,500.00 to \$17,000.00. The IRS has also increased the income limits for contributions to Roth IRA accounts. The phase out for contributions in 2012 to Roth IRAs will begin for individual filers at an adjusted gross income of \$110,000.00. Those with adjusted gross incomes in excess of \$125,000.00 will not be allowed to make any contribution to a Roth IRA. This is an increase from the 2011 phase out range of \$107,000.00 to \$122,000.00 of adjusted gross income. For joint filers the 2012 phase out range for Roth IRA contributions will be from \$173,000.00 to \$183,000.00 of adjusted gross income, an increase from the 2011 range of \$169,000.00 to \$179,000.00.

# ELECTRONIC FILING FOR 2011 TAX RETURNS

# THE LIGHT DOES NOT ALWAYS CHANGE, SO THE LAW DOES

Most drivers have experienced the feeling of sitting at a red light that seems like it will never change. For motorcycle and bicycle riders, however, this feeling was often a result of more than simple impatience. As many traffic lights are triggered by weight sensors in the road set to detect cars, the lights sometimes do not sense that a lightweight motorcycle or bicycle is waiting to proceed through an intersection. Therefore, the rider may not be given a green light until another vehicle approaches which is able to trigger a change.

A new law which took effect on January 1, 2012 addresses this issue. It applies to municipalities with populations under 2,000,000, which means it applies everywhere in Illinois except the City of Chicago. The law will allow motorcycle and bicycle riders to go through red lights after they have waited a "reasonable time", although they must still yield the right of way to other traffic. What is a "reasonable time" is not certain at this point, however. Governor Pat Quinn initially vetoed this law believing that a definite time of 120 seconds should be put into the law, but his veto was overridden. The original sponsor of the bill has introduced a follow up bill that would put a specific time period of 120 seconds into the law, but it has not been enacted. Although this history indicates that 120 seconds may be a reasonable amount of time to wait, police officers and judges will not be required to agree with this determination unless the law is amended to specifically include this time period.

# WAIT AND SEE:TAX LAWS UNCER-TAIN FOR 2012

When preparing tax returns for the prior year, it is often a good time to look forward to tax strategies for the year to come. Unfortunately, certain tax laws for 2012 are once again unsettled. One area that is particularly up in the air is allowable deductions. Many popular deductions expired on December 31, 2011. Although many are expected to be renewed for the 2012 tax year, Congress has not done so yet. Taxpayers must therefore wait to see which deductions will be available for this tax year, and what form any renewed deductions will take.

For the 2011 tax year, taxpayers had the option of deducting their state sales tax payments rather than state income tax payments on their federal tax return. Unless action is taken by Congress, this option will not be available in 2012. A limited deduction for classroom expenses for teachers who do not itemize has also expired, as have deductions for mortgage insurance premiums and certain educational expenses. The allowable deduction for qualified mass transportation expenses will be reduced from \$230 to \$125 for 2012 if no action is taken. Additionally, the Alternative Minimum Tax exemption levels will drop from \$48,450 for individuals and \$74,450 for married couples filing jointly in 2011 to \$33,750 for individuals and \$45,000 for joint filers in 2012. It has been estimated that this could potentially expose thirty-one million more people to the Alternative Minimum Tax this year.
