ILLINOIS ANNOUNCES DELAY IN TAX REFUNDS FOR EARLY FILERS

For lottery winners, agencies, school districts and businesses, news of delays in payments from the State of Illinois have become a familiar refrain. Illinois has recently announced that early income tax return filers who are entitled to refunds will be added to the list of those who can expect to wait for a check from the state. However, this delay does not appear to be related to the state's budget impasse or a lack of funds to make the payments. Rather, the state has announced that it will not begin making refund payments until March 1, 2016 in an attempt to combat fraud. The Illinois Department of Revenue stated that the delay will allow it to better detect attempts at identity theft, and to limit refunds made on fraudulently filed income tax returns.

NEW LAW ALLOWS PASSPORTS TO BE DENIED OR REVOKED FOR SERI-OUSLY DELINQUENT TAXPAYERS

Facing collection proceedings is always a difficult situation, especially when the creditor is the Internal Revenue Service. A recently passed law has given the IRS yet another weapon in its arsenal for the collection of delinquent taxes, one which may surprise and greatly inconvenience the unwary.

Included in a new transportation bill is a provision that requires the Secretary of State to deny or revoke the passports of seriously delinquent taxpayers. This applies to taxpayers who have an outstanding debt for Federal taxes greater than \$50,000. There are exceptions to this new law, including those who have entered into installment agreements or are seeking a hearing on the tax debt.

NEW DUI LAW ELIMINATES MANDATORY 30 DAY SUSPENSION

Beginning January 1st, individuals arrested for DUI in Illinois will no longer face a mandatory 30-day driving suspension. Illinois lawmakers overwhelmingly chose to eliminate the mandatory suspension in favor of a program that allows drivers to continue driving so long as they receive a special permit and install a breathmeasuring device in their vehicle to ensure they haven't been drinking. The new law received support from experts across the country and the popular anti-DUI group, Mothers Against Drunk Driving, who believe the law is a more effective way to limit drunk-driving, while still allowing individuals to continue living productive lives in a safe manner. According to supporters, the new law helps people safely and legally commute to work and take care of their family, while, hopefully, maintaining their sobriety.

THE ILLINOIS SECRETARY OF STATE SUSPENDS MAILING OF VEHICLE REGISTRATION RENEWAL REMINDER NOTICES

Due to funding issues relating to the state's budget impasse, the Illinois Secretary of State has announced that it is suspending the mailing of Vehicle Registration Renewal Reminder Notices as a cost savings measure. Motorists can sign up to receive email Reminder Notices by visiting the Secretary of State's website at cyberdriveillinois.com.

HAPPY HOURS ARE HERE AGAIN

Although it may come as a surprise to those who meet friends and co-workers for drinks after work, Illinois banned "happy hours" in 1989. Of course bars were still allowed to serve alcohol during the after work hours, and could offer entertainment or food specials. However, they were prohibited from discounting alcohol prices during a "happy hour" period. Illinois law required that the same price be charged for alcoholic drinks during the entirety of an operating day.

In July of 2015 Illinois' "happy hour" ban was repealed. Bars may now discount drink prices during "happy hour" periods not to exceed four hours a day or fifteen hours a week. These "happy hours" cannot take place after 10:00 p.m., and must be advertised at least seven days in advance. The law also places limits on the types of specials that can take place. For instance, although discounted prices are allowed, bars cannot offer "buy one get one free" or similar specials.

STUDENT CONCUSSION LAW

On August 3, 2015, Illinois Governor Bruce Rauner approved a new Illinois law changing the way schools analyze and handle head injuries and concussions. In enacting the law, the Illinois General Assembly recognized that concussions are one of the most commonly reported injuries in children and adolescents who participate in sports and recreational activities. The law, which took effect last August, applies to public and private schools alike.

Under the new law, students who suffer a concussion are required to get permission from a doctor or trainer before they may fully return to class or sports. The law further requires the governing body of each Illinois school with students who participate in interscholastic athletics to establish a concussion oversight team. Each concussion oversight team must establish a "return-toplay protocol," based on peer-reviewed scientific evidence consistent with the Centers for Disease Control and Prevention guidelines, for a student's return to practice, competition, or the classroom following a force or impact believed to have caused a concussion. Additionally, schools, park districts, and other organizations providing youth sports leagues are encouraged to distribute educational materials on the nature and risk of concussions and head injuries to coaches, game officials, players, and parents or guardians of players.
